Ensure that your supporters not only see the logo, but make sure to tell them about the high standards you have signed up to so they are encouraged to donate more, to give more regularly, and to give with confidence.

We are proud to represent more than 1,400 fundraising organisations that have embraced self-regulation, the high standards we aim to uphold and ensuring the sector as a whole maintains its regulatory independence. - ❖ We respect the rights, dignities and privacy of our supporters and beneficiaries
- ❖ We will not put undue pressure on you to make a gift and if you do not want to give or wish to cease giving, we will respect your decision
- ❖ If you tell us that you don't want us to contact you in a particular way we will not do so

We Are Fair and Reasonable

- ❖ We take care not to use any images or words that cause unjustifiable distress or offence
- ❖ We take care not to cause unreasonable nuisance or disruption

We Are Accountable

- ❖ If you are unhappy with anything we've done whilst fundraising, you can contact us to make a complaint
- ❖ We have a complaints procedure, a copy of which is available on request. If we cannot resolve your complaint, we accept the authority of the FRSB to make a final adjudication
